019-21/22: 1. Apologies – Cllr M Williams & CA Allan - The Committee resolved to accept these and record under the LGA 1972 Section 99 and Sch 12 para 40.

022-21/22: 4. Planning Applications –

- a) PL/2012/04643 – enclose existing roofed carport which is attached to house to create an enclosed garage at 2 School House Drive, SP11 9FY. The committee discussed and had no objections. Clerk to report to Wiltshire Planning.
- b) PL/2021/05919 – variation of condition 2 from application 18/04676/FUL - Erection of a dwelling with access and parking. The committee discussed and had no objections. Clerk to report to Wiltshire Planning.
- c) PL/2021/05964 – Demolition of existing rear garage and erection of new rear garage at Swithins, 57 Tidworth Road, SP11 9QE. The committee discussed and object to that the description above is not as per the plans, the new garage is attached to the house and a lot larger than the old one and could be used as a domicile. Should this planning application be passed LTC request that a condition be put on it that the garage can not be used as a dwelling.

023-21/22: 5. Applications Determined –

- a) 21/00078/FUL – Change of use from car valeting and vehicle repairs to meat cutting and packing facility, at Crown Garage 23 Andover Road, SP11 9LU – Withdrawn. The Committee asked the Clerk to request that when available that they are kept up to date with the information requested by LTC.
- b) PL/2021/03409 – Demolition of single-storey side extension, erection of two-story side extension, single story rear extension, modified front port and re-cladding the whole property in an outer brick skin at 13 Perham Crescent, SP11 9NL – approved with conditions.
- c) PL/2021/05192 – T1 Ash tree fell at 9 Springfields, Astor Crescent, SP11 9BW – approved with conditions.
