Budget/precept – the Clerk explained the increase of the RLE budget in detail, there is an £1000 increase in Maintenance costs (by Sept this year RLE have gone over budget by £500) and the main increase coming from £5000 for devolved services. Devolved services are those items that the Unitary Council decide they will not be funding in the future, such as, grass verges & rights of ways. This is something that Towns & Parish councils need to budget for, the majority of which will fall within the RLE remit. The committee were happy with the explanation and agreed that devolved services need to be budgeted for. It was suggested that a better explanation could be given to residents, to be discussed at FTC.   | Clerk |
