## Minutes of the Planning meeting held on 21st December 2020 remotely using Microsoft Teams at 6.15pm.

### AGENDA ITEM

**015-20/21:** 1. Apologies – Cllr B Cordery - The Committee resolved to accept these and record under the LGA 1972 Section 99 and Sch 12 para 40.

**016-20/21:** 2. Declaration of Interest – none.

**017-20/21:** 3. Planning Applications –

a) *Variation of Planning Permission 18/10543/FUL* (The development of Green Infrastructure including the importation of material and infill engineering works to the former test track to support the implementation of the approved Recreational Access Action Plan for the Army Basing Programme) in order to secure a revised landform and updated Materials Management Plan at Land at Corunna Barracks, Tidworth Road, Ludgershall, SP11 9RP. The Committee discussed the proposals and have no objections to these. Admin to notify Wiltshire Council.

b) *20/10902/TCA* – Sycamore tree – reduce limbs to West by 1.5m and re-balance crown at Castle Street, Ludgershall, SP11 9QR. The Committee discussed the proposals and have no objections to these. Admin to notify Wiltshire Council.

**018-20/21:** 4. Applications Determined – none

**019-20/21:** 5. *19/07329/TPO* – discuss. Cllr J White had raised at the previous meeting that the trees to the front of the property did not look like they had been fully felled and she had sent in a photograph to show a re-planted tree. The Committee looked at the photos and Cllr M Williams advised that the two half trees covered in ivy were there originally and the tree in the Planning Application had been fully felled to ground and another (very small) tree replanted. It was not possible to see what type of tree has been placed there, but it looks like all conditions have been adhered to so no further action is needed.

**020-20/21:** 6. *Wiltshire Council tree re-planting policy* – This is quite a lengthy document – Admin to send out to the Committee for discussion at a future meeting, if required.

**021-20/21:** 7. *Update on building site at end of Empress Way* – Admin advised that Cllr C Williams had received complaints from local residents about the mud and grit spilled along the road and over the bridge by the construction traffic. He has contacted Foreman Homes who provided a response to him advising that they are adhering to the regulations of wheel washing and road sweeping. Cllr Burgon agreed that this is the case as he walks up there most days. The committee also looked at the Construction Method Statement which is very basic. Cllr M Williams advised that on several occasions he has been waiting to cross the bridge and while sat at the traffic lights he has been behind over-full lorries waiting to turn left onto Astor Crescent that have dropped grit or wet

cement everywhere. All agreed that the trucks are being over-filled – this needs to be reported to Wiltshire Council – Admin to action.

**022-20/21:** 8. Agenda Points to be discussed for next meeting – none.
